(b) Trash Containers. The Owners of all Lots shall place their garbage and rubbish in sanitary disposal containers. #### **EC&R Article 12**

In view of the trash heaped on the roadside of Monroe Road, a review of the rules related to this problem is in order.

- (a) <u>Unsightly Objects</u> Visible Storage. All refuse and trash containers, outside clothes lines as permitted by law, oil or bottles, gas tanks, water softening equipment, air conditioners, swimming pool filter, pumps, and other similar items must be underground or hidden from view of all neighboring Lots by a landscaped hedge or wall or fence of sufficient height to totally conceal the equipment and it shall be architecturally attached to the dwelling structure as provided above.
- (b) <u>Trash Containers</u>. The Owners of all Lots shall place their garbage and rubbish in sanitary disposal containers. Garbage containers, refuse or lawn cuttings shall not be put out for collection until after 5:00 P.M., of the evening before collection and returned by 7:00 P.M. of the evening of collection.
- (f) <u>Trash/Dumping</u>. Dumping or placement of trash, refuse, grass cuttings, or yard debris of any kind on

## **USPS Mail Delivery**

GVE's snowbirds and year-round, but travelling, residents should be aware of the USPS mail delivery and non-delivery policies. The Venice Postal Annex (VPA) on Seaboard Avenue serves only the Zip Code 34293 which means GVE. The purpose of USPS PS Form 8076, Authorization to Hold Mail, is obvious. The form may be given to the GVE carrier, mailed or submitted via an online request at https:// holdmail.usps.com/holdmail/landingView.do. There is a choice of having accumulated mail delivered or personally picked up at the VPA by a date specified by the customer. The form states that mail may be held for a minimum of three (3) days, but not for more than thirty (30) days. The USPS will forward mail for up to one (1) year via an online request at https:// moversguide.usps.com/icoa/icoa-main-flow.do? execution=e1s1. to GVE. Should your original in-

any Lot or common property grounds within the Subdivision, is prohibited.

#### Storage and Disposal of Unsightly Lawn Refuse

The visible storage of unsightly lawn refuse anywhere on lots, including curbs, is not permitted by E,C&R paragraphs 12.(a-b). Refuse must be concealed from the view of all neighboring Lots. Lawn refuse for trash collection must be placed in sanitary disposal containers and shall not be placed on lot curbs until after 5:00 PM of the evening before trash collection. Lot owners are responsible for ensuring that lawn refuse generated either by themselves, their renters or their lessees, or lawn and landscaping maintenance contractors is concealed from view until placed curbside in sanitary disposal containers for trash collection or otherwise disposed of. As presented in other 2011 GVE Newsletters, your Homeowners Association has instituted a process for remedying an instance or instances of EC&R non-compliance that may culminate in a monetary fine. Keep GVE clean!

tended date of GVE arrival unexpectedly change from the resume GVE delivery date provided the USPS you may submit a timely Hold Mail request to prevent the USPS from returning your mail to sender or destroying it. Gaining time may prove important if all or most of your First Class Mail (bills, statements, property taxes, legal documents, etc) is delivered by the USPS versus online. Why? The USPS policy, whether or not adhered to by your GVE carrier, is to halt mail delivery to your GVE mailing address should mail not be removed from your mail box after five (5) mail delivery days. The VPA holds that mail for five (5) days then returns it to the sender or destroys it. No doubt many GVE residents have had mail sit in their mail box in excess of five (5) days, but the carrier may experience bad karma if his/her negligence is detected by the USPS Inspectors and GVE residents may experience bad karma if an important document is not received and therefore not acted on.
