## **January 16 Board Meeting**

Two representatives from our new management company attended the January meeting of the Board. The GVE manager, Lynn Lakel and owner, Michelle Thibeault of Sunstate Management. They came prepared and had ready answers to questions posed by members of the Board. There were about 26 owners in attendance and a larger room has been reserved for future meetings.

The updated EC&Rs have been duly registered with Sarasota County. Rental application procedures are a part of that document.

There are 15 properties in GVE that have created problems for the Association. They include bankruptcies, foreclosures and abandonment. Most often they

are unkempt and unsightly. The Association is paying for several to be mowed and kept within some degree of neatness. Seven of these lots are in arrears and owe money for annual dues, lot maintenance and/or attorney fees.

The invoices for the 2013 membership fee (which was reduced by \$10.00 this year) went out in December 2012, due January 1, 2013. As of February 1st, 68 have not been paid. These are the funds on which the yearly budget is based. It is a serious loss to the Association to deal, not only with delinquent lot owners, but also with those in residence who simply choose not to pay on time.

#### **Alliance Meeting**

Christine Robinson, County Commissioner, was the featured speaker at the January 10, 2013 meeting of the South County Alliance of Homeowners Associations.

River Road – the north end is on hold; the south end is to be paved and work is proceeding on the River Road/US41 Junction.

Home sales are up 29%; home prices up 11%. Tourism is up 12.8%.

The Budget is in good shape due to previous planning and the discovery that \$3 million in medical bills was paid in error for residents of other counties.

The County is allotting \$3.8 million for small business development.

Unemployment is 8.2%, but there are many jobs available throughout the County with a lack of technically qualified people to fill them. They are working with the schools to develop programs to help in this area.

Capital Projects include Alligator Creek Storm Water Project, River Road Paving, Snook Haven and the extension of Pine Brook in Venice to Honoré Avenue in Sarasota. Despite all these projects, we have the lowest tax rate in the state.

The next meeting is February 14, 2013, 9:00 AM, at Foxwood, SR776 in Englewood. The speaker is Elaine Willis of The Green Street Project.

#### **Grant Approved**

Our Grant was approved by the Sarasota County Commission January 30th. President Mike Shlasko has asked West Coast Lake & Wetland Management to schedule aquatics installation for mid-March assuming that plant material will be available earlier than expected due to the mild winter. Get your boots, water shoes and shovels ready for our community planting day. The exact date will be announced as soon as possible.

Mike Shlasko remarked, "Please think about projects that might be undertaken with grant funding assistance from the County. Now that we again have experience with the process and relationships with the new County Grant Coordinator, let's try to take advantage of available funding in the November Grant Cycle and plan for 2014

improvement projects."
