GREAT DAY FOR GVE PONDS

A beautiful day! A great success! Twenty seven volunteers reported to the GVE entrance Saturday, March 16, and placed 2,500 aquatic plants along the banks of the ponds.

Two representatives from West Coast Lake and Wetland Management divided them into teams of four: two who waded into the ponds with spades to ready the holes; one to move the four types of color coded plants from the staging area to the planters and one to coordinate them according to the plans provided. It sounds a little complicated, but the preparation was thorough and once the teams were apprised of the procedures, it went along so well that they managed to complete 1,000 feet along the pond

banks. Some were willing to get their clothes wet; some ran back and forth with the appropriate plants; some were on "alligator watch" and some sat as "sidewalk superintendents" providing bottles of water and cookies to the workers thanks to the two ladies who brought the goodies. It takes all kinds of volunteers to accomplish such a large undertaking and there was a remarkable response from residents. Thank you!

The entire project was well organized; the results extraordinary. GVE will probably realize a sizable reimbursement from the Sarasota County Beautification grant fund.

Annual Fees Unpaid

Gulf View Estates is a beautiful, dynamic community including people from many walks of life. It is well run by an elected Board of Directors who plan carefully to retain and preserve the integrity of the Association and the atmosphere of the community.

It can become very costly to you to involve a lawyer's fees plus fines and ultimately a lien on your property.

SCAHA March Meeting

The March business meeting of the Alliance featured a speaker from the Englewood Water District which while informative was not relevant to the residents of Gulf View Estates as we are in the Sarasota County Water District.

The Presidents Lunch which followed was attended by County Administrator Randall Reid who was the featured speaker as well as by County Commissioners Nora Patterson and Christine Robinson. Charles Hines who represents the South county area including Gulf View did not attend. Approximately 30 residents of Alliance Communities attended representing a majority of the 22 Associations in the Alliance.

Administrator Reid spent a great deal of time reviewing his diverse background and commenting upon the current and historic quality of the governance in Sarasota County and the importance of long range planning, economic development, maintenance of the social safety net, protection of our environment and a strong tax base. I personally came away with the impression that we have a very strong County Administrator who in his first year has developed an excellent understanding of our County and who can call upon a lifelong career in Public Administration to help move Sarasota County forward.

The next meeting will take place on April 11 at 9AM.

Doggie Toilets?

There are several areas of common property within GVE that are being used as "doggie toilets". The offenders need to know that they are being watched. One dog walker comes out after dark to the grassy area along Pierce Drive.

If you care about your animal, you should also be responsible for it and that means cleaning up after it.

Anyone who sees a dog owner leaving a mess anywhere in the neighborhood should report it to a member of the Board and to the Sarasota County Code Enforcement. There is not only a rule against it in GVE "Easements, Covenants & Restrictions, Article III, Section 7(B)", but it is a County ordinance as well.

Trash at the Curb

Neighbors do not want to look at anyone's trash sitting at the curb for a week. The GVE Easements, Covenants & Restrictions cover this issue explicitly in "Article III, Section 2, Trash Collection". No trash may be placed at the curb before 5:00 PM the evening before collection. Containers must be retrieved by 7:00 PM on collection day. This rule includes all landscape debris some of which can be taken away by your landscaper.
