Our GVE Home Owner's Association is operated by volunteers. These volunteers are chosen and supervised by our elected Board of Directors. It is a tribute to our volunteers that GVE remains a pleasant place to live with a very low annual fee.

Elections for the Board of Directors are held as part of our Annual Meeting. To run for a position on the Board you should apply to the GVE Nominating Committee on or before **October 25, 2013.** You should provide written notice that you desire to run and want to have your name listed as a candidate on the materials included within the Second Notice of the GVE Annual Meeting. The attached "*Notice of Intent to be a Candidate for the Board*" may be used for that purpose. You should also include a one-sided (8 1/2 x 11 inch) Information Sheet supporting your qualifications for the Board of Directors.

Please note that members may also be nominated from the floor at the annual meeting. Members receiving nominations from the floor will not have their name and Information Sheet included within the Second Notice nor will their name be included on the mailed ballot.
