April 18 Board Meeting

The agenda for the April Board meeting was covered in one and a half hours. Numerous topics were discussed and debated.

There is a sum of \$2,489 in uncollected fees. Five homeowners are still in arrears on annual fees. Three letters have been sent out and fines will be levied which may result in liens being placed on those properties. Some of these scofflaws are the same people who default every year until threatened with the lien action. It is costly to the Association to pay for all the mailings and the lawyer fees.

One non-compliance issue, long overdue, has been resolved hopefully by Sunstate calling the owner to a meeting to discuss ways to bring the property into compliance. A plan was put in place whereby the necessary steps were laid out and a schedule drawn up for completion. The owner agreed to the plan and completion of the requirements will result in the \$300 fine being waived.

A so-called "clean slate" letter will be sent out to all homeowners in Gulf View Estates stating in essence that the Board (and several Boards before now), is well aware that the cement block wall enclosing a garage on Roosevelt Drive was done illegally and without regard for the EC&R rules. It is now under different ownership. The letter will make it abundantly clear that such architectural changes will not be tolerated in the future.

Vice President Resigns

Bruce Jenkins took on the role of Board Member when Mike Shlasko resigned and finished out that term. He was then convinced to run for the 2018 Board of Directors.

His inability to attend the Wednesday afternoon meetings was not by choice, but by his commitment to his job. He is a school department employee and felt, as we all do, his first commitment was to the safety of the students. With recent events, it has become necessary to have repeated lockdowns of our local schools. It meant that he was often detained beyond his usual school hours in the afternoon.

After lengthy discussion between Mr. Jenkins and the other Board members, it was decided that it would be best for all concerned if he resigned. He did so gracefully and now the Board is lacking a seventh member.

GVE Road Resurfacing

At left is a spreadsheet that shows the results of the inspection that I requested of the County representative, Rohini Bobba.

I have looked into having the roads resurfaced because we have not heard from the County in quite some time!

I was in contact many times with the County person, Rohini Bobba. Rohini has come to my house and explained how the inspection of the roads is done. Rohini has checked every street in Gulf View Estates. They use the calculations from the inspection and if they come up with any measurements that are below 50 then the road may be resurfaced.

Unfortunately, our roads are still above the 50 mark. I will request an inspection every year so our roads will be taken care of. I was told we were on a list for resurfacing to be done in 2020. Someone from the County removed Gulf View Estates from the County list about 1 1/2 years ago. Be assured I will be following through with this.

At the same time, the Board is extremely concerned with speeding vehicles, particularly on Roosevelt and Pierce Drives. We are also looking into any possible resolutions to combat this ongoing problem. There have been some close calls reported. Children and adults alike are at risk because of the drivers who do not respect the 25 mph speed limit in Gulf View Estates.
