Page 7 Article III

6. Parking and Prohibited Vehicles. All vehicles must be parked on driveways or in garages and shall not be parked otherwise on yards or Lots at any time. No vehicles may be parked on the streets within the subdivisions between the hours of 11:00 p.m. in the evening and 6:00 a.m. the next morning, Sarasota, Florida, local time

(a) No vehicle may be repaired in open view of any Lot Owner from any angle within the subdivisions except within a garage

(b) Vehicles not registered to operate on public roads as required by Florida Law, trucks over 3/4 ton, commercial vehicles, vehicles with commercial writing on their exteriors or with commercial equipment visible, vehicles primarily used or designed for commercial purposes, tractors, mobile home, recreation vehicles or equipment, trailers (either with or without wheels), campers trailers, boats and other water craft, and boat trailers, shall be parked only in enclosed garages.
