Board Business

The annual meeting was held on December 9. A quorum of the residents was not present, so the meeting was held open until January 19, so that more proxies could be collected. If you have not submitted a proxy and will be unable to participate in the January 19th meeting, please send a proxy to Sean Noonan at Sunstate or drop it off in the mailbox by the bulletin board.

Here are the highlights of the annual meeting:

- VP William Hulshoff reported that the contractor for road repair in Phase 1 of the community has been selected. There was a discussion of updating the streetlights to LEDs at no cost to the community.
- Mike Doyle, Treasurer stated that power cost was up 3%. We have a new landscaping company and a
 corresponding increase in expense. Management fees and insurance are both up. The \$10 increase in
 annual dues was approved. Our new dues are \$225 (which is still much lower than most other similar
 communities). The institutional owners of foreclosure on Harrison is not responding to any notices and
 the board is trying to get a valid address to contact them.
- Ron Werks ARC says that ARC requests can be approved easily and in a timely manner if they are
 accompanied by the proper paperwork detailing drawings and specs for any external changes to
 houses.
- Next year's Annual Meeting will return to the normal 6PM time.
- Newsletters will be available in the box by the bulletin board (a limited number), via email, posted on GulfViewEstates.com, and delivered by request (contact the editor).
- The south shore of the pond is deteriorating and requires erosion control at a cost of \$80/foot.
- The entrance center island has an electrical problem which is being addressed. This should fix the lighting that shines on the flag.
- The exterior wall color was selected by the board working as the elected representatives of the community. It was a majority vote choosing from a palette of colors provided by the contractor.
- A monthly informal Sunset Event at Manasota Key was discussed. More info forthcoming.
- The management company will request a meeting with the Ventura Village board to allow the Roosevelt owners affected by the property line question a forum to discuss the issue.
- New board member John Brown was approved.
