# **Annual Community Meeting Notes**

- President's Report: Minutes of the previous annual meeting were approved. Two members of the Board of Directors tendered their resignations during the past month: John Unnersall has resigned and were thanked for his unselfish community service.
- Resident's Comments: The issue of unscreened and open pools was raised again. There are some pools that have no enclosures in our community. It makes no difference if this is due to storm damage or insurance issues, it is illegal. Florida has specific laws mandating that pools must be enclosed. If your pool is open, you are exposing yourself to more than mosquitoes. Instead of an itchy bite, you might get fined or, possibly worse, be held liable for personal injury. Please take action to enclose your pool with a screen enclosure. (Note-this is an ongoing issue.) Open pool owners will now receive Compliance Violation letters and will run the risk of eventually getting fined.
- **Vice President's Report:** Nothing this time.
- **Treasurer's Report:** We are operating within our budget, but, due to unexpected legal expenses, our annual dues will remain at \$265 per year. Authorization issue for treasurer to access bank statements is in process.
- Secretary's Report: Bonnie McGuigan is retiring from the board. She received a round of applause for her years of service.
- Management Company Report: There were sufficient attendees and proxies received to constitute a quorum at the Annual Meeting. Although there were not enough volunteers to fill all board seats (thus negating the requirement for an election), the membership voted to roll the 2023 budget surplus over into 2024 where it will be applied to ongoing expenses.
- Landscape Committee: Residents are encouraged to report any problems they see with the irrigation at the front entrance to any board member.
- **Maintenance Committee:** The Holiday lights were installed at the front entrance and many commented they look better than ever. Over \$1000 in installation fees was saved by John Rathvon and volunteers by installing the ground lighting.
- **Street Committee:** The resurfacing of the remainder of the community is supposed to be on the county's schedule, but there has been no action as yet. Residents are encouraged to take extra care, including being considerate of others, when exiting the community. Traffic is high during the winter months and people come by GVE at high rates of speed. We do not want to have a fatality on our doorsteps.
- **Compliance Committee:** A workshop was held in November to ensure Board members understand compliance issue handling according to Florida Statutes. Compliance issues are now being addressed and enforced with potential fines. The hiatus occasioned by Hurricane Ian is now over.
- Architectural Review Board: No requests this month. With the retirement of John Untersall, Eric Martell has agreed to be the new ARB contact.
- Newsletter committee: Browsing through the newsletter could save people time and effort. Please note that all board members' contact information is always included on the last page.
- **Events Committee:** This is a new committee, since our Food Truck events have proven to be popular. The chairs are Kim Baigert and Rosanna Gibbons. They are working to collect a Hobby interest list.
- **Street Ambassador Committee:** We have 32 volunteers, but additional volunteers are still needed. Delivering the newsletter is a great way to meet neighbors. The Ambassadors received plaudits from the Board for their diligence and helpfulness. They welcomed 25 new homeowners to GVE in 2023. The 50/50 raffle proceeds from the Food Truck events go to the Ambassador Program overhead.
- Unlawful Activities: Nothing to report.
- **Unfinished business:** A new and more visible No Soliciting sign will be posted at our entrance in an effort to discourage solicitors. Compliance issues with properties are included in the estoppel reports to Title Companies engaged in closing property sales. This could delay or interfere with a sale, so please address issues immediately, if you receive a compliance letter from the management company. Fines have been mostly waived since Hurricane Ian, but will be imposed beginning in January.
- New Business: Budget for 2024 was discussed, amended slightly, and approved by the Board.
- The Meeting was closed, however, the Board remained for a brief executive session to discuss outstanding legal issues.
