## **April Board Meeting Notes**

- **President's Report:** Minutes of the prior monthly meeting minutes and the organizational meeting were approved. President recognized several residents for their volunteer work in making GVE a desirable community. If your street has a pothole, call 311 and let Sarasota County know.
- **Resident's Comments:** Discussion about the exit gate on Wilson leading to Ventura being opened in case of emergency. It remained locked throughout Hurricane Ian. The problem is that Ventura streets are private. The issue regarding the fence on Garfield is still pending.
- **Vice President's Report:** Nothing to report at this time.
- **Treasurer's Report:** A new Portal to Management Company services is pending. GVE's bank account will be moved to Truist as part of that change. Seven percent of the community has not paid 2024 dues as of this time. Eleven are non-payments over 90 days in arrears and their accounts have been sent to the HOA attorney for collection.
- Secretary's Report: Nothing to report at this time.
- Management Company Report: Still some dues are still outstanding. Please send them in. Sunstate is working on updating their database. Everyone needs to update their record to ensure the new Portal operates correctly. The form for you to update your record is posted on the website at GulfViewEstates.com. No compliance fines were levied for the previous period. However, several homes are on the list due to compliance issues.
- **Landscape Committee:** 2 bids were received. More are being solicited. We need one company to do both landscaping and irrigation.
- Maintenance Committee: A new No Soliciting sign was placed at the entrance. It is colorful and should be more visible. The island curbs were repainted to highlight them. Several cars have struck the front curb and that probably resulted in alignment issues or wheel damage. Take care when entering.
- **Street Committee:** Residents are encouraged to take extra care, including being considerate of others, when exiting the community. Traffic is high during the winter months and people come by the GVE entrance at high rates of speed. We do not want to have a fatality on our doorsteps.
- Compliance Committee--Repeated from previous newsletter due to Importance: Compliance enforcement began in February. If you receive a letter, do not ignore it. Damaged roofs that still require repair must be repaired or fines will be imposed. The compliance procedure is governed by State Statute 720 and GVE must follow that statute. The state says that anything in direct view from any adjacent property falls under the compliance purview. A violation reporting form has been placed on the website. The Board voted to reduce the per day fine from \$100 to \$50 and to continue the prior practice of applying the fine from the first day the homeowner was notified of the violation. This means that, if you get a compliance notice, you should immediately contact the management representative (info at top of the newsletter), find out specifically what you need to do, and then get it done. If you wait until the 3<sup>rd</sup> notice, you may incur a hefty fine. Note that the EC&Rs limit the maximum fine for any one compliance issue to \$3000. The Community Compiance Drive-thru is done by a licensed Community Manager.
- **Architectural Review Committee:** There were two requests for minor alterations. Both were approved rapidly. There was one request for repainting a house this action does not require approval as long as the earthtone or pastel pallet prevalent in the neighborhood is followed.
- **Newsletter committee:** We are moving to our Summer schedule. There will be no home delivery for the next few months. Delivery will be via email only, although there will be a limited number of printed copies placed in the newsletter box and a copy placed on the bulletin board.
- **Events Committee:** The Saturday Sunset Get Together was held at Manasota Beach on March 20 and was a relaxing time for attendees. It will be a continuing monthly event.
- Street Ambassador Committee: Additional volunteers are still needed. The Board recognized Lynn O'Neill for the outstanding job she has done as head of the Ambassador program.
- Unlawful Activities: Nothing to report.
- Unfinished business: Eric Martell agreed to install Alligator/Snake Warning Signs. A suggested location for posting such signs was the back side of the benches along the pond.
- New Business: Eric Martell discussed a possible board approved No Trespassing and No Soliciting signs that could be placed in a window. This was tabled until next meeting.
- The meeting was adjourned.
